## NOTICE OF PUBLIC DEDICATION

NOTICE is hereby given that the Matanuska-Susitna Borough, a municipal corporation organized and existing under the laws of the state of Alaska, whose address is 350 East Dahlia Avenue, Palmer, Alaska 99645, hereby dedicates to the public a 100 foot wide public use easement located in Sections 1 and 12, Township 26 North, Range 6 West, Seward Meridian, Alaska, located in the Talkeetna Recording District, depicted by the Record of Survey dated March 24, 1998, and described by the legal description dated March 23, 1998, attached here as Exhibit A.

PURSUANT to Matanuska-Susitna Borough Code 23.10.110, said easement is dedicated by the Matanuska-Susitna Borough Manager under approval dated April 24, 1997, subject to the following conditions:

- 1. The term is indefinite; and
- 2. The easement will not exclude any type of vehicle or type of transportation, however vehicles with a gross weight of one thousand (1000) pounds or greater, or which produce ground pressure of more than three and one-half (3 1/2) pounds per square foot, must have written permission from the borough to use the public use easement, until such a time that a road or trail is constructed to accommodate heavier vehicles.

This dedication is an official public document of the Matanuska-Susitna Borough.
